On July 17, 2025, Mega Fortune Company Limited ("MGRT" or the "Company"), an Internet of Things ("IoT") solution provider in Hong Kong, announced the closing of its initial public offering (the "Offering") of 3,750,000 ordinary shares at a price of \$4.00 per share. The ordinary shares began trading on the Nasdaq Capital Market on July 16, 2025, under the ticker symbol "MGRT." The Company has granted the underwriter a 45-day option to purchase up to an additional 562,500 ordinary shares at the public offering price, less the underwriting discounts. The aggregate gross proceeds from the Offering were \$15,000,000, before deducting underwriting discounts and other related expenses.
