## D. Boral Capital Acted as Sole Bookrunner to Xsolla SPAC 1 (Nasdaq: XSLL) in Connection with its ~\$204,000,000 Initial Public Offering

#### Transaction Information

On January 30, 2026, Xsolla SPAC 1 closed its Initial Public Offering of 20,000,000 units at a price of \$10.00 per unit. The units began trading on the Nasdaq Global Market under the ticker symbol “XSLLU” on January 29, 2026. Each unit consist of one Class A ordinary share and one-half of one redeemable warrant to purchase one Class A ordinary share. Its Class A ordinary shares, units and warrants are listed on the Nasdaq Global Market under the symbols “XSLL”, “XSLLU” and “XSLLW,” respectively. On February 2, 2026, Xsolla SPAC 1 closed on its partial exercise of the over-allotment of 419,385 units at a price of \$10.00 per unit. This resulted in gross proceeds for the Offering of ~\$204,000,000.
